1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

The Shurparaka Educational and Medical Trust, established in 1984, is a prestigious academic institution in Palghar District, India. Founded in 1984, the college has broadened its degree offerings to accommodate students from economically disadvantaged backgrounds. The college's impact in academics and performance in university exams has been commendable, with 1059 students enrolled at the degree level, including professional courses. The college provides five undergraduate programs: Bachelor of Arts, Bachelor of Commerce, Bachelor of Management Studies, Bachelor in Accounting and Finance, and M.Com. (Accountancy) at the postgraduate level. In 2013, the college introduced self-financed courses like BMS, BFM, BAF, and BSC (IT) to offer professional skills and practical knowledge. The college has initiated numerous additional/certificate courses. The college adheres to the syllabus of the University of Mumbai and utilizes a credit-based semester evaluation system. Faculty members frequently participate in workshops, seminars, and meetings focused on syllabus revisions, organized by the University or other institutions. The college strives to prepare students for their professional success and foster an environment that promotes holistic growth. The college offers students a platform for exploration and experimentation, with the Student Council actively supporting the administration and engaging in diverse activities. The college's management and trustees are actively involved in overseeing the institution's operations, regularly convening meetings with the Principal and staff. They support faculty empowerment and promote professional growth through grants for teachers presenting papers at conferences. The college has enhanced its ICT facilities, including a well-stocked library with a diverse range of resources such as textbooks, reference books, journals, magazines, newspapers, and epublications. Institutional Weakness

- The majority of the students are first-generation college students from low socio-economic backgrounds.
- Since many new colleges have come up in the area, it has become difficult to enroll the required number of students. Hence, the enrollment ratio is lower.

- The students will have the opportunity to cultivate social values through a diverse range of social and community outreach initiatives.
- To initiate the implementation of courses that focus on developing skills and adding value, thereby enhancing the future prospects of students.
- To enhance the connection between academia and industry by fostering a deeper understanding of knowledge and its practical application, as well as creating more opportunities for professional placements.
- To offer learners the chance to gain practical knowledge through internship opportunities. The college is working to make the most of the available academic and infrastructural resources in order to provide the students with a quality and outcome-based education. The institution has all the features to pursue autonomy in the future. Despite having a number of limitations, the institution has great potential to flourish in many areas and can improve its admissions in the future with its strategic goals.

The institution's annual financial report, including infrastructure updates, is sanctioned by the Governing Body. Prior to appraising the governing body, the staff and principal deliberated on the infrastructure facilities. Tuition and contributions serve as the primary

Underachievers take extra lessons and receive oral communication training. Education and research use PPT, LCD projectors, computers, Wi-Fi, and Libraries. Numerous multimedia resources are available to aid education.
- A total of 112 computers are interconnected via a Local Area Network (LAN). The internet connection boasts a speed of 25 megabits per second. All administrative tasks, including admissions, are completely automated. CCTV is implemented with the intention of enhancing security. There is parking available for both faculty and staff members, regardless of their teaching status. Staff and students use lifts
- Commerce and IT have labs on the third and sixth floors. The seminar hall has extensive seating, an LCD projector, a screen, and an audio setup.

The elected students of each committee work with the teachers to coordinate a variety of activities. The institution routinely organises numerous initiatives to boost capability.
- The college's IQAC regularly promotes competitive exam preparation, career assistance, soft skills development, remedial programmes for struggling learners, yoga and meditation, and personal counseling. The annual celebrations of the university are highlighted in the student publication "Splash." Digital access to "Splash" is available on the college's website.

Financial aid enables students from low-income households to access education and receive academic support. The College offers concessions and installment options for financially disadvantaged students.

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

- The educational institution affiliated with Mumbai University assumes the responsibility of creating an Academic Calendar that facilitates the various aspects of teaching, learning, and assessment. The college website serves as a platform for accessing the calendar, while the respective stream coordinators are tasked with generating the schedule for both the website and notice board. The primary objective of the college is to establish a conducive and safe atmosphere for learning, which promotes intellectual development and responsibility. The goal is to improve people's lives by gaining knowledge, being intellectually excellent, having moral values, developing talents, and nurturing virtuous individuals.
- The Principal organises meetings with faculty members to create the yearly curriculum plan in alignment with the University's guidelines. They develop customised Action Plans for their individual departments, focusing on the subject matter and specific goals of their respective areas. Every teacher follows the annual curriculum, and the IQAC collects input from both teachers and students. The coordinators actively engage in departmental review meetings to supervise extracurricular endeavours, including remedial coaching, student seminars, assignments, and curriculum advancement.
- The college library offers a diverse array of resources to support teaching, learning and research. These resources include books, journals, magazines, newspapers, course syllabi, exam question papers, project and electronic materials. The college procures literary and scholarly publications from the library in order to correspond with syllabus revisions implemented by the University. The college has access to N-List ICT and library resources, which are supported by INFLIBNET for educational instruction. Additionally, Google Classroom provides study resources that aid in the process of learning.
- The college is required to adhere to the rules and regulations set by Mumbai University. This includes implementing a choice-based credit and semester system for both undergraduate and post graduate programmes. The college has implemented systems for ongoing internal assessment and evaluations at the end of each semester. The Continuous Internal Evaluation (CIE) system is utilised to internally assess student performance. Teachers have a crucial role in stimulating student engagement by asking questions and creating a positive learning atmosphere.
- The college creates the academic calendar every year, and the college's IQAC is in charge of putting together the calendar for academic, co-curricular, and extracurricular activities. The committees take part in activities throughout the entire year.
- At the commencement of the Academic year, the faculties furnish students with extensive information regarding each subject, encompassing various aspects such as the types of papers, examination protocols, allocation of marks, assignments, and other relevant particulars.

The college campus covers an area of 2120 square meters and houses various facilities, including 25 classrooms, the principal's office, the administrative office, the IQAC room, the girls common room, the computer center, two staff rooms along with Coordinator Staff Room, the career counselling room (Trust Room), store rooms, and a lift. The educational process necessitates teachers to employ innovative methods to maintain student engagement. The college possesses ample lecture rooms that cater to both academic and extracurricular activities. These rooms are equipped with desks, fans, and permanently installed tube lights.

Classrooms: Students engage in enthusiastic learning within large, well-ventilated classrooms that are painted and equipped with essential teaching tools such as mounted LCD projectors, white screens, and a podium.

Conference Room: The conference room is furnished with a projector system, LCD, air conditioning, and internet connectivity, accommodating more than 150 individuals.

Computer Labs: The college has two modern computer labs equipped with up-to-date software and strong anti-virus protection with 112 computers, and projectors.

Library: The library provides a diverse range of literature, such as textbooks, reference materials, rare books, magazines, journals, and electronic publications. The library utilises SOUL, an integrated library management system, which includes electronic journals and a plagiarism detection tool called X plagiarism checker. The second floor includes newspaper stands, new arrival boards, a printer, a Xerox machine, a reading area, and a separate reference area.

The college possesses a 225-seat auditorium equipped with a screen, LCD projector, podium, and audio system. This facility is utilised for lectures, conferences, and cultural events. Information regarding the college's various activities can be accessed on its website. Additionally, the college has access to Hansha internet connections with SME capabilities.

counselling office: The college's counselling office offers regular counselling sessions to support students in their personal and academic development. The college's placement cell facilitates career exploration for undergraduate students by establishing connections with reputable companies and

The library is fully automated and utilises the Integrated Library Management System (ILMS) SOUL 3.0 from INFLIBNET. The space encompasses 169 square meter and houses a collection exceeding 11292 books, journals, magazines, and periodicals. Books were purchased over the past five years. The library houses a specialised collection of sports, professional/competitive examination literature, and dictionaries. The library is open from 8:00 a.m. to 4:00 p.m. on weekdays.

To accommodate a sufficient number of students, distinct areas have been designated for research experts and college teachers. CCTV cameras have been installed in the library to enhance surveillance. In addition, the library offers reprographic services such as printing and copying. There are five accessible fire safety units available. WIFI is available at the library. Students retrieve their identification cards from the library. Students also have book borrowing privileges. SOUL 3.0 is a library automation system developed by INFLIBNET for managing libraries. The library uses the programme for administrative tasks like data entry, book issuing, returning, renewal, and member logins. The Dewey decimal system organises books. OPAC lets users search for books by title, author, or publisher. It can also search the book collection. Each user has a unique barcode ID, and the books have barcodes. The library has N-list materials and printed books from the e Shodh Sindhu collaboration of the INFLIBNET consortium. These resources let faculty and students' access and download databases, e-books, and other digital content. The stand and racks show new books and journals. Booksellers can showcase their books in the library.

We get books and journals based on what the faculty suggests. There is a library committee. The library committee meets often to improve the library.

The HEI focuses on maintaining the library as a valuable resource. The funds are for buying books, getting old question papers, and improving services for stakeholders.

- The main office is equipped with a laptop, a scanner, a printer, and Internet connection. There are computers, printers, and Wi-Fi available in the staff room.
- The IQAC Cell has a computer, scanner, and printer with Internet access.
- Strategically positioned, large digital screens facilitate the continuous display of notices and other vital information for the students.

The Institute has adopted a strong financial management system to optimise resource utilisation for academic and administrative progress. The main source of institutional revenue is student fees, which are determined by the University's fee structure. Fees and grants received from funding agencies are documented separately.

The fees collected for Sports, Cultural, Library, Laboratory, and Student Welfare categories contribute to maintaining the college and improving student facilities. The Management has created a corpus fund and allocated it to fixed deposits. We maintain records of the generous letters of donation and sponsorship we receive from our supporters. The Finance and Accounts Department ensures proper execution of all significant financial transactions, both incoming and outgoing, in accordance with the appropriate procedures. University exam payments and enrolment are solely done electronically and recorded with Tally ERP 9 software.

Financial audits and internal audits are important control systems that help with governance and risk management in organisations. Audits evaluate financial statements, controls, and compliance. External auditors conduct a Financial Audit to assess an organization's financial statements. It includes looking at financial records and transactions. To encourage wealthy community members to donate more money, we need effective strategies that inspire their generosity.

Each year, we conduct a financial audit within our institution. The audit is done by a team consisting of the principal, office superintendent, and a senior faculty member. The college checks its financial records thoroughly, including fee collection, purchases, and other expenses. We verify the college's financial transactions every year to make sure they are accurate and reliable. An external audit is done by a certified Chartered accountant from M/S Fakih & Co.

The college has a yearly event where students display their cultural talents and encourage national unity. The Self-finance and History Departments go on trips to different areas of Maharashtra annually to visit industries and historical sites. Tours help students learn about different regions, cultures, socio-economics, and languages. It teaches about different cultures. College programmes for Independence Day and Republic Day are served as honour. These exercises will make students responsible citizens who will work hard for the nation's success. Some of the students being of lower income groups did not even have their own smart phones so some teachers staying nearby came to the college even in this crucial pandemic and supported those students by handing over the smartphone & notes to such student so they could learn even at this phase.
- 3. **Teaching Aid** Students and teachers both being new to online methods of teaching and learning faced various difficulties to get adopted and flexible to this virtual learning. Teachers then first learnt the virtual mode and then imported this knowledge to learn to use the various apps relating to online learning.
- 4. **Psychological Aid** As every home had turned into a classroom so it became more and more difficult to keep a control over the students. To keep the students intact with the academic as well as psychological needs, our college teachers and principal sir conducted counselling sessions to emotionally and mentally cope up with the pandemic situations.

Evidence of success - The success can be measured through the mental behavior of students pre and post COVID taking virtual teaching into account. Students succeeded with good academic scores. The other challenges of finance and technical assistant also proved a success, many students and their families surpassed the crisis dealt in physical, financial and psychological aspects.

Problems encountered -
